Eye contact: Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist

examination.

Ingestion: Wash out mouth with water. Do not induce vomiting. If unconscious, check for breathing

and apply artificial respiration if necessary. If unconscious and breathing is OK, place in
