	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Contact lenses may pose a special hazard; soft contact lenses may absorb and concentrate irritants. · Use approved positive flow mask if significant quantities of dust becomes airborne.
