Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. The air velocity at the extraction fan, for example, should be a minimum of 4-10 m/s (800-2000 f/min) for extraction of crusher dusts generated 2 metred distant from the extraction point. As defined in AS/TM F.739-96 in any application, gloves are rated as: Excellent when breakthrough time > 20 min Fair when breakthrough time > 20 min Poor when glove material degrades For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended. It should be enphasized that glove thickness typically greater than 0.40 representation. Therefore, glove selection should also be based on consideration of the task requirements and knowledge of br
