4.1. Description of first aid measures

Clean-up procedures: Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

Storage conditions: Store in cool, well ventilated area. Keep container tightly closed. The floor of the storage room must be impermeable to prevent the escape of liquids. Store under Argon. Recommended storage temp 2-8 °C.
