6.3. Methods and material for containment and cleaning up

Minor Spills	 Material from spill may be contaminated with water resulting in generation of gas which subsequently may pressure closed containers. Hold spill material in vented containers only and plan for prompt disposal Eliminate all ignition sources. Cover with DRY earth, sand or other non-combustible material. Then cover with plastic sheet to minimise spreading and to prevent exposure to rain or other sources of water. 	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source.
