# Exposure controls

|                         | Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed<br>engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to<br>provide this high level of protection.<br>The basic types of engineering controls are:<br>Process controls which involve changing the way a job activity or process is done to reduce the risk.<br>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation<br>that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if<br>designed properly.
