Velocity generally decreases with the square of distance from the extraction point (in simple cases). As defined in ASTM F-739-96 in any application, gloves are rated as: • Excellent when breakthrough time > 480 min • Fair when breakthrough time > 20 min • Fair when breakthrough time > 20 min • For when glove material degrades For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended. It should be emphasised that glove thickness is not necessarily a good predictor of glove resistance to a specific chemical, as the permeation efficiency of the glove will be dependent on the exact composition of the glove model. • The decision to use respiratory protection should be based on professional judgment that takes into account toxicity information, exposure measurement data, and frequency and likelihood of the worker's exposure - ensure users are not subject to high thermal loads which may result in heat stress or distress due to personal protective equipment (powered, positive flow, full face apparatus may be an option).
