	Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. The basic types of engineering controls are: Process controls which involve changing the way a job activity or process is done to reduce the risk. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application. The exact break through time for substances has to be obtained from the manufacturer of the protective gloves and has to be observed when making a final choice. Personal hyginer is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly.
