The basic types of engineering controls are: Process controls which involve changing the way a job activity or process is done to reduce the risk. Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Seconding to EN 374, AS/NZS 2110.1 or national equivalent is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 80 minutes according to EN 374, AS/NZS 2110.1 or national equivalent is recommended Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for long-term use Contaminated gloves should be replaced.
