4.1. Description of first aid measures

Section 5: Fire-fighting measures

5.1. Extinguishing media

Extinguishing media: Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used. Use water spray to cool containers.

5.2. Special hazards arising from the substance or mixture

Exposure hazards: Flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes. Hydrogen bromide (HBr).
