6.3. Methods and material for containment and cleaning up

	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. • Where protection from nuisance levels of dusts are desired, use type N95 (US) or type P1 (EN143) dust masks. Use respirators and components tested and approved under appropriate government standards such as NIOSH (US) or CEN (EU)
