5.2. Special hazards arising from the substance or mixture

Exposure hazards: Flammable. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NOx).

5.3. Advice for fire-fighters
