Eye and face protection	 Safety glasses with side shields. Chemical goggles. A written policy document, describing the wearing of lenses or restrictions on use, should be created for each workplace or task. • The decision to use respiratory protection should be based on professional judgment that takes into account toxicity information, exposure measurement data, and frequency and likelihood of the worker's exposure - ensure users are not subject to high thermal loads which may result in heat stress or distress due to personal protective equipment (powered, positive flow, full face apparatus may be an option).
