	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. The air velocity at the extraction fan, for example, should be a minimum of 4-10 m/s (800-2000 f/min) for extraction of crusher dusts generated 2 metres distant from the extraction point. 	Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended. Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include:  1 frequency and duration of contact,  2 othernical resistance of glove material,  2 glove thickness and  2 dextripy  Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739, AS/NZS 2161.1 or national equivalent).  When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time  greater than 240 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.  When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time  greater than 240 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.  Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for  long-term use.  Contaminated gloves should be replaced.
