## 5.2. Special hazards arising from the substance or mixture

**Exposure hazards:** Flammable. Vapour may travel considerable distance to source of ignition and flash back. Forms explosive air-vapour mixture. In combustion emits toxic fumes of carbon dioxide / carbon monoxide. Nitrogen oxides (NOx). Hydrogen cyanide (HCN).
