7.1. Precautions for safe handling

Therefore, glove selection should also be based on consideration of the task requirements and knowledge of breakthrough times. For example: Thinner gloves (down to 0.1 mm or less) may be required where a high degree of manual dexterity is needed. However, these gloves are only likely to give short duration protection and would normally be just for single use applications, then disposed of.
