### 2.1. Classification of the substance or mixture

**Section 5: Fire-fighting measures**

**5.1. Extinguishing media**

**Extinguishing media:** Carbon dioxide, dry chemical powder, foam. Suitable extinguishing media for the surrounding fire should be used.
