**2. HAZARDS IDENTIFICATION**

**Main hazards:** Harmful by inhalation, in contact with skin and if swallowed.

**3. COMPOSITION / INFORMATION ON INGREDIENTS**

**Hazardous ingredients:** 4-CYANOPIPERIDINE, N-BOC PROTECTED >90%

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be irritation and redness at the site of contact.  
**Eye contact:** There may be irritation and redness. The eyes may water profusely.  
**Ingestion:** There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting.  
**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

**4. FIRST AID MEASURES (ACTION)**

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Consult a doctor.  
**Eye contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.  
**Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Consult a doctor.  
**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

**5. FIRE-FIGHTING MEASURES**

**Extinguishing media:** Suitable extinguishing media for the surrounding fire should be used. Carbon dioxide. Dry chemical powder.  
**Exposure hazards:** In combustion emits toxic fumes.  
**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

**Clean-up procedures:** Transfer to a closable, labelled salvage container for disposal by an appropriate method.
