Methods and material for containment and cleaning up

Minor Spills	 Remove all ignition sources. DO NOT touch or walk through spilled material. Clean up all spills immediately. Avoid contact with skin and eyes. Prevent dust cloud. With clean shovel (preferably non-sparking) place material into clean, dry container and cover loosely. Move containers from spill area. Control personal contact with the substance, by using protective equipment.
Major Spills	 Clear area of personnel and move upwind. Alert Fire Brigade and tell them location and nature of hazard. DO NOT touch or walk through spilled material. Control personal contact with the substance, by using protective equipment. Prevent, by any means available, spillage from entering drains or water course. No smoking, naked lights or ignition sources. Increase ventilation. Stop leak if safe to do so. Contain or cover with sand, earth or vermiculite. Use only spark-free shovels and explosion proof equipment. Collect recoverable product into labelled containers for recycling. Collect solid residues and seal in labelled drums for disposal.
