Hands/feet protection	The selection of suitable gloves does not only depend on the material, but also on further marks of quality which vary from manufacturer. The exact break through time for substances has to be observed when making a final choice. Personal hygine is a key element of effective hand care. Gloves must only be worn on clean hands.
