As defined in ASTM F-739-96 in any application, gloves are rated as: - Excellent when breakthrough time > 400 min - Fair when breakthrough time > 20 min - Paor when glove material digove thickness typically greater than 0.35 mm, are recommended. It should be emphasied that glove thickness is not necessarily a good predictor of glove resistance to a specific chemical, as the permeation efficiency of the glove with a shickness typically greater than 0.35 mm, are recommended
