### 4.1. Description of first aid measures

place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.

#### 4.2. Most important symptoms and effects, both acute and delayed

**Skin contact:** There may be redness or whiteness of the skin in the area of exposure. Irritation or pain may occur at the site of contact. Absorption through the skin may be fatal.

**Eye contact:** There may be severe pain. The eyes may water profusely.
