**2. COMPOSITION / INFORMATION ON INGREDIENTS**

**Hazardous ingredients:** 5-CHLORO-2-FLUOROTOLUENE >90%

**3. HAZARDS IDENTIFICATION**

**Main hazards:** Irritating to eyes, respiratory system and skin. Flammable.

**4. FIRST AID MEASURES (SYMPTOMS)**

**Skin contact:** There may be irritation and redness at the site of contact.

**Eye contact:** There may be irritation and redness. The eyes may water profusely.

**Ingestion:** There may be soreness and redness of the mouth and throat.

**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest. Exposure may cause coughing or wheezing.

**4. FIRST AID MEASURES (ACTION)**

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Wash immediately with plenty of soap and water.

**Eye contact:** Bathe the eye with running water for 15 minutes. Consult a doctor.

**Ingestion:** Wash out mouth with water. Consult a doctor.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. Consult a doctor.

**5. FIRE-FIGHTING MEASURES**

**Extinguishing media:** Suitable extinguishing media for the surrounding fire should be used. Carbon dioxide. Dry chemical powder.

**Exposure hazards:** In combustion emits toxic fumes.

**6. ACCIDENTAL RELEASE MEASURES**

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using bunding.

**Clean-up procedures:** Absorb into dry earth or sand. Transfer to a closable, labelled salvage container for disposal by an appropriate method.

**7. HANDLING AND STORAGE**

**Handling requirements:** Avoid direct contact with the substance. Ensure there is sufficient ventilation of the area. Do not handle in a confined space. Avoid the formation or spread of mists in the air. only use in fume hood

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed.

**Suitable packaging:** Must only be kept in original packaging.
