## 4.1. Description of first aid measures

  - **Ingestion:** Wash out mouth with water. Do not induce vomiting. If conscious, give half a litre of water to drink immediately.   - Inhalation: Remove casualty from exposure ensuring one's own safety whilst doing so. If conscious, ensure the casualty sits or lies down. If unconscious and breathing is OK, place in the recovery position. If unconscious, check for breathing and apply artificial respiration if necessary.
