Eye Contact	 If this product comes in contact with the eyes: Wash out immediately with fresh running water. 	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. Waste treatment methods
