Description of first aid measures

Eye Contact	 If this product comes in contact with the eyes: Wash out immediately with fresh running water. Methods and material for containment and cleaning up

Minor Spills	 Environmental hazard - contain spillage. Clean up all spills immediately. Avoid breathing vapours and contact with skin and eyes. Place in a suitable, labelled container for waste disposal.
