### 2.1. Classification of the substance or mixture

## Section 4: First aid measures

### 4.1. Description of first aid measures

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Transfer to hospital if there are burns or symptoms of poisoning.

**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

## 4.3. Indication of any immediate medical attention and special treatment needed

### 6.1. Personal precautions, protective equipment and emergency procedures

If outside keep bystanders upwind and away from danger point. Mark out the contaminated area with signs and prevent access to unauthorised personnel. ### 7.1. Precautions for safe handling
