Eye Contact

Important factors in the selection of gloves include: Irequency and duration of contact, chemical resistance of glove material, glove thickness and dive thickness and When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374, ASI/XIS 2161.10.1 or national equivalent). When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 240 minutes according to EN 374, ASI/XIS 2161.10.1 or national equivalent) is recommended. Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for long-term use. Contaminated gloves should be replaced. As defined in ASTM F-739-96 in any application, gloves are rated as: Excellent when breakthrough time > 20 min Good when breakthrough time > 20 min Poor when glove material edgrades For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended. It should be emplassed that glove thickness is not necessarily agod predictor of glove resisting. Therefore, glove selection should also be based on consideration of the task requirements and knowledge of breakthrough times.
