## 5.2. Special hazards arising from the substance or mixture

**Exposure hazards:** Highly flammable. Forms explosive air-vapour mixture. Vapour may travel considerable distance to source of ignition and flash back. In combustion emits toxic fumes. Carbon oxides. Hydrogen chloride (HCl). Hydrogen fluoride (HF).
