Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use.</li> <li>Employers may need to use multiple types of controls to prevent employee overexposure.</li> <li>General exhaust is adequate under normal operating conditions. 	Simple theory shows that air velocity falls rapidly with distance away from the opening of a simple extraction pipe. Velocity generally decreases with the square of distance from the extraction point (in simple cases). Therefore the air speed at the extraction point should be adjusted, accordingly, after reference to distance from the contaminating source. 	<ul> <li>When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.</li> <li>When only brief contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended.</li> <li>Some glove polymer types are less affected by movement and this should be taken into account when considering gloves for long-term use.</li> <li>Contaminated gloves should be replaced.</li> <li>As defined in ASTM F-739-96 in any application, gloves are rated as:</li> <li>Excellent when breakthrough time &gt; 480 min</li> <li>Good when breakthrough time &lt; 20 min</li> <li>Fair when breakthrough time &lt; 20 min</li> <li>For general applications, gloves with a thickness typically greater than 0.35 mm, are recommended.</li> <li>It should be emphasised that glove thickness is not necessarily a good predictor of glove material.
