4.1. Description of first aid measures

Exposure hazards: In combustion emits toxic fumes. Carbon oxides. Nitrogen oxides (NO_x). Hydrogen bromide (HBr). Hydrogen fluoride (HF).

5.3. Advice for fire-fighters
