Hands/feet protection	The selection of suitable gloves does not only depend on the material, but also on further marks of quality which vary from manufacturer to manufacturer. Where the chemical is a preparation of several substances, the resistance of the glove material can not be calculated in advance and has therefore to be checked prior to the application. The exact break through time for substances has to be observed when making a final choice. Personal hygiene is a key element of effective hand care. Gloves must only be worn on clean hands. After using gloves, hands should be washed and dried thoroughly. Application of a non-perfumed moisturiser is recommended. Suitability and durability of glove type is dependent on usage. Important factors in the selection of gloves include: - ifrequency and duration of contact, - identical resistance of glove material, - glove thickness and - dextrity Select gloves tested to a relevant standard (e.g. Europe EN 374, US F739, AS/NZS 2161.1 or national equivalent). - When prolonged or frequently repeated contact may occur, a glove with a protection class of 5 or higher (breakthrough time greater than 240 minutes according to EN 374, AS/NZS 2161.10 r national equivalent) is recommended. - When only bried contact is expected, a glove with a protection class of 3 or higher (breakthrough time greater than 60 minutes according to EN 374, AS/NZS 2161.10.1 or national equivalent) is recommended. - Contaminated gloves should be replaced. As defined in ASTM F-739-96 in any application, gloves are rated as: - Secollent twen breakthrough time < 20 min - So or when breakthrough time < 20 min - Fair when breakthrough time < 20 min - So or when glove material or the exact composition of the glove material, as the permeation efficiency of the glove with the equivalent than 0.35 mm, are recommended.
