**2.1. Classification of the substance or mixture**

**4.2. Most important symptoms and effects, both acute and delayed**

**Skin contact:** There may be irritation and redness at the site of contact.

**Eye contact:** There may be irritation and redness. The eyes may water profusely.

**Ingestion:** There may be soreness and redness of the mouth and throat. Nausea and stomach pain may occur. There may be vomiting.

Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid. Eliminate all sources of ignition.

Do not handle in a confined space. Avoid the formation or spread of mists in the air.  
Smoking is forbidden. Use non-sparking tools. Only use in fume hood.

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed. Keep away from sources of ignition. Prevent the build up of electrostatic charge in the immediate area.  
Ensure lighting and electrical equipment are not a source of ignition. Moisture sensitive.  
Store under Argon. Recommended storage temp 2-8 °C.
