**4.1. Description of first aid measures**

**4.3. Indication of any immediate medical attention and special treatment needed**

Treat symptomatically.

The toxicity of nitrates and nitrites result from their vasodilating properties and their propensity to form methaemoglobin.

- ▶ Most produce a peak effect within 30 minutes.
- ▶ Clinical signs of cyanosis appear before other symptoms because of the dark pigmentation of methaemoglobin.
- ▶ Initial attention should be directed towards improving oxygen delivery, with assisted ventilation, if necessary. Hyperbaric oxygen has not demonstrated conclusive benefits.
- ▶ Institute cardiac monitoring, especially in patients with coronary artery or pulmonary disease.
- ▶ Hypotension should respond to Trendelenburg's position and intravenous fluids; otherwise dopamine may be needed.
- ▶ Naloxone, glucose and thiamine should be given if a multiple ingestion is suspected.
- ▶ Decontaminate using Ipecac Syrup for alert patients or lavage for obtunded patients who present within 2-4 hours of ingestion.
- ▶ Symptomatic patients with methaemoglobin levels over 30% should receive methylene blue. (Cyanosis alone, is not an indication for treatment). The usual dose is 1-2 mg/kg of a 1% solution (10 mg/ml) IV over 5 minutes; repeat, using the same dose if symptoms of hypoxia fail to subside within 1 hour.

Refrigerated storage of peroxides must ONLY be in explosion-proof units.</b></li> <li>· The hazards and consequences of fires and explosions during synthesis and use of oxidisers is widely recognised; spontaneous or induced decomposition may culminate in a variety of ways, ranging from moderate gassing to spontaneous ignition or explosion. The heat released from spontaneous decomposition of an energy-rich compound causes a rise in the surrounding temperature; the temperature will rise until thermal balance is established or until the material heats to decomposition,</li> <li>· The most effective means for minimising the consequences of an accident is to limit quantities to a practical minimum. Even gram-scale explosions can be serious. Once ignited the burning of peroxides cannot be controlled and the area should be evacuated.</li> <li>· Unless there is compelling reason to do otherwise, peroxide concentration should be limited to 10% (or less with vigorous reactants). Peroxide concentration is rarely as high as 1% in the reaction mixture of polymerisation or other free-radical reactions,</li> <li>· Oxidisers should be added slowly and cautiously to the reaction medium. This should be completed prior to heating and with good agitation.</li> <li>· Addition oxidisers to the hot monomer is extremely dangerous. A violent reaction (e.g., fire or explosion) can result from inadvertent mixing of promoters (frequently used with peroxides in polymerisation systems) with full-strength oxidisers</li> <li>· Organic peroxides are very sensitive to contamination (especially heavy-metal compounds, metal oxide salts, alkaline materials including amines, strong acids, and many varieties of dust and dirt). This can initiate rapid, uncontrolled decomposition of peroxides and possible generation of intense heat, fire or explosion. The consequences of accidental contamination from returning withdrawn material to the storage container can be disastrous.</li> <li>· When handling <b>NEVER</b> smoke, eat or drink.</li> <li>· Always wash hands with soap and water after handling.</li> <li>· Use only good occupational work practice.</li> <li>· Observe manufacturer's storage and handling recommendations contained within this MSDS.</li> </ul>

<b>Storage incompatibility</b>	<ul style="list-style-type: none"> <li>▶ Contact with acids produces toxic fumes</li> <li>▶ Inorganic peroxy compounds are potent oxidisers that pose fire or explosive hazards when in contact with ordinary combustible materials.</li> <li>▶ Inorganic peroxides react with organic compounds to generate organic peroxide and hydroperoxide products that react violently with reducing agents.</li> <li>▶ Inorganic oxidising agents can react with reducing agents to generate heat and products that may be gaseous (causing pressurization of closed containers). The products may themselves be capable of further reactions (such as combustion in the air).</li> <li>▶ Organic compounds in general have some reducing power and can in principle react with compounds in this class. Actual reactivity varies greatly with the identity of the organic compound.</li> <li>▶ Inorganic oxidising agents can react violently with active metals, cyanides, esters, and thiocyanates.</li> <li>▶ Peroxides, in contact with inorganic cobalt and copper compounds, iron and iron compounds, acetone, metal oxide salts and acids and bases can react with rapid, uncontrolled decomposition, leading to fires and explosions.</li> <li>▶ Inorganic reducing agents react with oxidizing agents to generate heat and products that may be flammable, combustible, or otherwise reactive. Their reactions with oxidizing agents may be violent.</li> <li>▶ Incidents involving interaction of active oxidants and reducing agents, either by design or accident, are usually very energetic and examples of so-called redox reactions.</li> </ul> <p>for metal nitrates:</p> <ul style="list-style-type: none"> <li>▶ Segregate from heavy metals, phosphides, sodium acetate, lead nitrate, tartrates, trichloroethylene,</li> <li>▶ Avoid shock and heat.</li> <li>▶ Mixtures of metal nitrates with alkyl esters may explode due to the formation of unstable alkyl nitrates.</li> <li>▶ Mixtures of a nitrate with phosphorous, tin(II) chloride and other reducing agents may react explosively.</li> <li>▶ Mixtures containing nitrates and organic materials are potentially dangerous, especially if acidic materials or heavy metals are present.</li> <li>▶ Fibrous organic material, jute, wood and similar cellulosic material can become highly combustible by nitrate impregnation</li> <li>▶ Metal nitrates are incompatible with cyanides, thiocyanates, isothiocyanates and hypophosphites. **8.2. Exposure controls**

<p><b>8.2.1. Appropriate engineering controls</b></p>	<p>Engineering controls are used to remove a hazard or place a barrier between the worker and the hazard. Well-designed engineering controls can be highly effective in protecting workers and will typically be independent of worker interactions to provide this high level of protection.</p> <p>The basic types of engineering controls are:</p> <p>Process controls which involve changing the way a job activity or process is done to reduce the risk.</p> <p>Enclosure and/or isolation of emission source which keeps a selected hazard "physically" away from the worker and ventilation that strategically "adds" and "removes" air in the work environment. Ventilation can remove or dilute an air contaminant if designed properly. The design of a ventilation system must match the particular process and chemical or contaminant in use. Employers may need to use multiple types of controls to prevent employee overexposure.</p> <ul style="list-style-type: none"> <li>▶ Local exhaust ventilation is required where solids are handled as powders or crystals; even when particulates are relatively large, a certain proportion will be powdered by mutual friction.</li> <li>▶ If in spite of local exhaust an adverse concentration of the substance in air could occur, respiratory protection should be considered.</li> </ul> <p>Such protection might consist of:</p> <p>(a): particle dust respirators, if necessary, combined with an absorption cartridge;</p> <p>(b): filter respirators with absorption cartridge or canister of the right type;</p> <p>(c): fresh-air hoods or masks.</p> <p>Air contaminants generated in the workplace possess varying "escape" velocities which, in turn, determine the "capture velocities" of fresh circulating air required to effectively remove the contaminant.</p>
