Potassium iodide [7681-11-0] <0.01%, Sodium molybdate (VI) dihydrate [10102-40-6] <0.01%, Cupric sulfate pentahydrate [7758-99-8] <0.01%, Cobalt chloride hexahydrate [7791-13-1] <0.01%.
